
DEFENSIVE EQUITY STRATEGY

OVERVIEW

This strategy attempts to build a diversified portfolio consistently invested in most major economic sectors as defined by the S&P 500. We focus on approximately 25-35 high quality companies that have delivered stable and consistent returns through the business cycle. This strategy seeks a balance of income and growth with competitive returns. The goal of the strategy is to provide returns competitive with the S&P 500 with lower risk and volatility, as measured by beta.





The MSCI USA Minimum Volatility (USA) Index is an investment for minimum variance equity strategies. The index reflects a minimum variance strategy applied to U.S. large and mid-cap companies. The companies are selected based on their provision of the lowest return variance for a given matrix of stock returns. This is calculated by using the Borra Optimizer, which centers around mean variance portfolio optimization.

Beta is a measure of a stock's volatility in relation to the overall market. By definition, the market has a beta of 1.0, and individual stocks are ranked according to how much they deviate from the market.
